## Student Behavior Covenant

### Student Behavior Expectations

You will treat others with respect and understand that we are living in a community setting and that boundaries will be expected. Behavior disruptive to the community as well as the property will NOT be tolerated. You must abide by curfews, quiet times and physical boundaries (inside, outside, including equipment use of any kind). You will also be sure to check in with designated leaders throughout the student ministry event as necessary. We expect that every student will respect God, property, one another, staff and all adult leaders. We expect that every student will follow the event schedules and participate with the group. We also expect that students will dress in a way that is both respectful of themselves and others.

### Student Non-Negotiables

Your parents will be contacted and you could be sent home immediately for any of the following behaviors:

1. Use or possession of alcohol, illegal drugs, tobacco products of any kind.
2. Possession of firearms, knives, lighters, fireworks, other explosives or any other kind of weapon.
3. Unauthorized use or mistreatment/destruction of the facilities/grounds of the church or off-site visited.
4. Leaving the designated areas or grounds without permission from an adult leader or church staff.
5. I will follow the schedule of activities set for me by adult leaders and church staff.
6. Disrespect towards any adult leader or student from our church as well as others.
7. Use of inappropriate, profane or abusive language or conversation with any adult leader or student.
8. Use of cell phone during undesignated times (i.e. devotion, lesson, prayer, worship)
9. Inappropriate sexual behavior. I also will not enter and room with the opposite sex or seclude myself from the rest of the group with someone of the opposite sex.
10. All my actions will display a Christian example because I understand that I am always representing the church even if I am not a current member.

### Student Participant's Covenant Pledge

*I agree to follow the non-negotiables listed above so that I will be a part of the best environment possible for my spiritual growth during student ministry events and programs. This is an agreement I have made and I promise to adhere to these non-negotiable expectations.
